Mr. McNeil, Executive Director said we approved the Budget last month and now we are adopting it this month.

Chairman Williams called for a motion to adopt Resolution No. 5530-19 Resolution of the Board of Commissioners of the Housing Authority of the City of Orange to eliminate the Central Office Cost Center Fund. Vice Chairman Juliano moved to adopt. Commissioner Rimes seconded.

Chairman Williams called for discussion No discussion A roll call was taken All Commissioners voted in favor

Mr. McNeil, Executive Director stated that the letter with a copy of the check for reimbursement is in the Board of Commissioners package from Feinstein, Raiss, Kelin, Booker and Goldstein goes back to a claim with PSE&G from 2008 was just settled.
