EXECUTIVE DIRECTOR'S REPORT

Commissioner Juliano suggested we have a Social Worker come to the building.

McNeil advised him that we provide a variety of services to the staff and we have an OHDC Board member who is a Counselor who provides services to the residents when it's requested. McNeil also reviewed the public housing report with the board.

McNeil advised the board that the Chairman was able to secure an \$800K grant from the County of Essex.

Frank Glien reviewed the Audit report with the Board. He stated that his report is that HACO is in compliance with the federal and that there are no significant deficiencies, no material weaknesses in internal control of the financial report.

Chairman Williams called for a motion to adopt Resolution No. 5726-23 - Resolution accepting the public bid for cycle painting at Washington Manor and direct the Executive Director to execute a contract with Romaniello General Painting, LLC.

McNeil informed the Board that we have to reject the bid.

Marsha Moore, Esq., explained that the bid was being rejected because it had defects, i.e., insurance documents, no references, etc., the bidder did not provide the relevant information needed. He was the only bidder.

Chairman Williams called for a motion to adopt a walk on Resolution No. 5727-23 rejecting the public bid for cycle painting at Washington Manor and direct the Executive Director to execute a contract with Romaniello General Painting, LLC.

Ross asked if the trucks that we were donating/disposing had been picked-up. Dawn advised they had been.

Ross also inquired about our attempts to have the mobile DMV come to the building. Cristina advised that she was working on scheduling a date and she is waiting for a reply. McNeil advised the board that the Surrogate's Office came to the building to discuss Wills and Powers of Attorney with the tenants.

McNeil also advised that the Chairman spent time at the County and was able to secure a grant for \$800K to help offset the cost for WGIV.

Ross requested to attend the meeting on January 26, with the Cannabis Organization that was coming to the building to discuss the use of cannabis on the property.

Chairman called for a Motion to adjourn the meeting Commissioner Jackson moved to adopt. Commissioner Ross seconded Meeting adjourned.
